



COORDINATION MEETING REPORT 20th-21th June 2017, Ljubljana - Slovenia

Tuesday 20th June

Morning session

We were greeted by teachers and children of Jelka Kindergarten, who organised an enjoyable moment with songs and dances.

Later on we visited the school, that includes 13 groups of children.

Feedback and observations:

- well organised spaces and corners;
- mixed goups of children of different ages (e.g. 1-2, 2-4, 3-5, 4-5);
- mixed group of teachers: non only women but also some men;
- families involvement in the everyday life: once a month there's "open day" that is a playing moment in the morning with parents interested in participating;
- different teachers skills: the activities take into account the specific skills and passions of teachers (e.g. about music, dance, musical instruments, art, languages, art,...);
- outdoor activities;
- palying without toys: the kindergarten is involved in a project about unstructured materials and plays. This project is based on the reflection about how parents play with their children (adults seems don't know how to play). Therefore, the school can find and experiment new ways and strategies that could be preferred at home too;
- beautiful and interesting sensorial path with a lot of herbs.

In light of the observations emerged, we discussed about the meaning of "participation", sharing the same challenge: to welcome and give value the different modes, styles of participation, in order to include, understand everyone without judging.

Slovenian partner showed his power point presentation about families and community participation. Each partner, before the meeting, prepared a presentation, using the same power point template. This instrument was created in order to facilitate comparison and sharing among partners. It' divided into 4 parts:

- 1. Regulatory framework
- 2. Modes and tools of participation
- 3. What we do (best practices)
- 4. What we want to improve (challenges).

Afternoon session

Italian and Swedish partners illustrated their presentation.

Thursday 21th June

Morning session

We visited 2 kindergarten: Unit Palčki and Unit Vila.

We decided the date of the next meeting in Ljubljana: January 23th and 24th.

We planned and shared the definitive organisation of job shadowing. Each teacher involved in the J.S. has to acquire her/his Euro Pass mobility, in order to certify skills and know-how. All information to fill out the form are on the website http://europass.cedefop.europa.eu/.

We decided to offer teachers the opportunity to stay in two schools during J.S in Ljubljana: 2 days in a school and 3 days in another one. We also resumed the J.S. framework, arranged during the first meeting; we made some changes to improve the organisation of working days.
